NOTIFICATION

The Governor has been pleased to allow the following Medical Officers of the West Bengal Health Service who have completed 8(eight) years' continuous and satisfactory service from the date(s) of their regular appointment in the said service without any promotion and now enjoying the scale of pay of Rs.8,000 - 275 - 13,500/- (Scale No.16) and its corresponding revised Scale under Pay Band 4A i.e. Rs./-15,600-42,000/-+Grade Pay of Rs.5,400/-taken together, to move to the next higher scale of pay of Rs.10,000 - 325 - 15,525/- (Scale No.17 of WBS ROPA '98) and its corresponding revised Scale under, Band-4A, 15,600-42,000/-+Grade Pay of Rs.6,600/-under W.B.S.(ROPA) Rules,2009, with effect from the date(s) as mentioned against each of their names and allow them to continue in their present places of posting until further orders.

2. On their entitlement to the higher scale of pay of Rs.10,000 - 325 - 15,525/- (Scale No.17) and its corresponding revised Scale of Pay, Band-4A, 15,600-42,000/-+Grade Pay of Rs.6,600/-under W.B.S.(ROPA) Rules,2009, the pay of the concerned Medical Officers shall be fixed in terms of Finance Department's Notification No.3015 – F, dt.13.03.2001. Besides, the said Medical Officers would also be entitled to the pay and allowances as admissible to them in terms of rules & orders of the State Government in force from time to time.

3. While giving the effect to the above benefits to the concerned Medical Officers the date(s) of their joining the West Bengal Health Services on regular basis, **AND NOT ON ADHOC BASIS**, as also continuity of the service should strictly be verified by the heads of the institutions vis-à-vis the entries in their Service Books. Discrepancies, if any subsequently been found, shall immediately be brought to the notice of this Department for taking further necessary action prior to giving effect to this order in respect of the said concerned Medical Officers.

The above benefit has been awarded under the modified career advancement scheme in terms of the Finance Department's Notification No.3015 – F, dt.13.03.2001.
