NOTIFICATION

The Governor has been pleased to allow Shri Ananda Dulal Jana, Sr. Lecturer, now posted at Institute of Pharmacy, Bankura, who has completed 16 (sixteen) years' continuous and satisfactory service from the date of his regular appointment in the said service and with one advancement to the next higher scale and now enjoying the scale of pay of PB Rs. 10,000 – 325 – 15,200/- with AGP of Rs.7,000/- to move to the next higher scale of pay of PB Rs.12,000 -420 – 18,300/- with AGP of Rs.8,000/-, with effect from 30.06.2016 and to allow him to continue in his present place of posting until further orders.

Besides, the said Officer would also be entitled to the pay and allowances as admissible to him in terms of rules & orders of the State Government in force from time to time.

While giving the effect to the above benefits to the concerned Officer the date of his joining the West Bengal Health Services on regular basis, AND NOT ON ADHOC BASIS, as also continuity of the service should strictly be verified by the heads of the institution vis-à-vis the entries in his Service Book. Discrepancies, if any subsequently be found, shall immediately be brought to the notice of this Department for taking further necessary action prior to giving effect to this order in respect of the said concerned Officer.

The above benefit has been awarded under the modified career advancement scheme in terms of the Finance Department's Memo. No. 3015-F, dt. 13.03.2001.


