ORDER

The undersigned is directed by order of the Governor to say that the Governor has been pleased to create 1(one) post of State Programme Coordinator and 1(one) post of State Programme Assistant at the State Headquarter and 29 (Twenty Nine) posts of District Programme Coordinator and 29 (Twenty Nine) posts of District Programme Assistant for placement at the District BMP Cell i.e. total 60 (sixty) posts on contractual basis for implementation of Maternity Benefit Programme namely Bangla Matri Prakalpa under Pradhan Mantri Matru Vandana Yojana (PMMVY) which is a Direct Conditional Cash Transfer Scheme for pregnant & lactating women for first live birth. Under this scheme, a cash incentive of Rs. 5000/- (rupees five thousand only) would be transferred directly in the account of "Pregnant Women and Lactating Mothers" (PW&LM) in 3 (three) instalments for first living child of the family subject to their fulfilling specific conditions relating to Maternal and Child Health. It is estimated that about 8 (eight) lakhs Pregnant Women and Lactating Mothers would be benefitted through this scheme in our State, every year.
