As the Kolkata Police Hospital at 2, Benianandan Street, Kolkata-700025, earlier under administrative control of Home & Hill Affairs Department, Govt. of West Bengal, was declared a part of the IPGME&R-SSKM Hospital, Kolkata under Department of Health and Family Welfare and subsequently was taken over by IPGME&R-SSKM Hospital, Kolkata, the Health & Family Welfare Department, Govt. of West Bengal, has felt the need to shift 24 contractual posts out of 107 contractual posts of different categories created in Kolkata Police Hospital under Department of Home and Hill Affairs with the approval of FD vide UO No. 1693, Group P (Service) dated 30/05/2012 and with the approval of the Cabinet in the meeting held on 20/06/2012 to IPGME&R-SSKM Hospital under Department of Health and Family Welfare to render proper patient care services at the Institute.

In pursuance of the aforementioned decision, the undersigned is directed by order of the Governor to say that the Governor has been pleased to accord approval for shifting of 24 contractual posts in different categories created in Kolkata Police Hospital under Department of Home and Hill Affairs to IPGME&R-SSKM Hospital under Department of Health and Family Welfare. The remaining contractual posts in Kolkata Police Hospital under the Department of Home and Hill Affairs are hereby abolished. The details of such 24 contractual posts shifted from Dept. of HHA to the Department of Health and Family Welfare are annexed herewith.
