ORDER

The undersigned is directed to say that the Governor has been pleased to accord Administrative Approval for (a) creation of 577 (five hundred seventy seven) posts of different categories and (b) engagement of 270 (two hundred seventy) no. of posts of Female GDA (135) and House Keeper/Sweeper (135) on contractual basis through agency for operationalisation of 14 Trauma Care Facilities on National Highways at various tiers of Government Hospitals across the State.
