Order

The CBMWTF operators in the State are presently facing a huge task in handling COVID wastes from COVID hospitals as well as similar wastes from Isolation wards of other hospitals housing SARI / COVID suspect patients. As a result, bulk bio-medical wastes, mainly contributed by PPEs, gloves & masks being used as protective gear, are being generated by these hospitals from July, 2020. Subsequently, for the four CBMWTF operators, mentioned below, an amount of Rs 3,74,75,599/- (Rupees three crore seventy four lakh seventy five thousand five hundred and ninety nine only) has already been paid out of COVID-19 fund to the said agencies by the SAMITI for disposal of bio-medical wastes from COVID hospitals and Isolation wards for COVID suspect patients of other hospitals including labs. The health facility wise break-up is given below and the concerned CMOHs / Directors / Principals are hereby directed to take necessary steps to inform all concerned MSVPs / Superintendents of the health facilities as well as concerned Pay & Account Offices and Treasuries in this regard. The CBMWTFs are:

1. **Medicare Environmental Management Pvt. Ltd** – disbursed amount Rs. 1,16,49,702/- (Rupees one crore sixteen lakhs forty nine thousand seven hundred and two only) up to September, 2020
2. **SNG Envirosolutions Pvt. Ltd.** - disbursed amount Rs. 1,38,04,795/- (Rupees one crore thirty lakh four thousand seven hundred and ninety five only) up to September, 2020
3. **Greentech Environ Management Pvt. Ltd** - disbursed amount Rs. 64,30,550/- (Rupees sixty four lakhs thirty thousand five hundred and fifty) only up to September, 2020
4. **Greenzen Bio Pvt. Ltd** - disbursed amount Rs. 55,90,552/- (Rupees fifty five lakhs ninety thousand five hundred fifty two only) up to August, 2020
