ORDER

It is to reiterate that Covid services had been scaled down vide Order bearing number HFW-18014/2/2022-PHP Sec/65 dated 25.02.2022 of this Department. But reportedly, the CBMWTF operators are still claiming bills in Special Covid Rates as per Order vide no. 181-HS(MS)/HFW-40043/13/2018 dated 24.09.2020 for lifting, transportation, and disposal of bio-medical wastes from all bedded / non-bedded health facilities where physically no functioning Covid beds exist. In the aforesaid order dated 24.09.2020, it was clearly mentioned "the rate will continue till the period Covid 19 remains a disaster under West Bengal Epidemic Diseases, Covid19 Regulation, 2020".


So, it is hereby being drawn to the kind notice of all concerned that the previous Order vide no. 181-HS(MS)/HFW-40043/13/2018 dated 24.09.2020 has become inoperative with effect from the date of withdrawal of Covid services from the respective health facilities and the lifting, transportation, and disposal of bio-medical wastes from all bedded / non-bedded health facilities across the State should be accomplished at the pre-Covid rate, as approved by this Department, and such disposal from different U-PHCs should be done in terms of Order no. 98 – HS(MS)/HFW-27038/90/2018/Part(1) dated 13.06.2022 of this Department. This Order is issued with the approval of the Principal Secretary of this Department.
