ORDER

To combat probable 3rd surge of Covid-19 cases, it requires immediate provision of new Covid beds, augmentation of general and CCU/HDU beds at existing Covid hospitals, setting up of MGPS, laboratory, diagnostic facilities etc. Thus, PWD has been requested to take up requisite civil and electrical works at the concerned health facilities. Accordingly, estimates have been received from PWD through Principal, Dr B C Roy PGIPS for following works with request to issue AAFS:

1	Emergent repair and renovation work for Corridors from Ground Floor to 2 nd floor including replacing of damaged door, windows, grill and outside face of North side of Polio Building for next wave of Covid 19 pandemic during the year 2021-22 at Dr B C Roy Hospital, Belegkata campus	5,14,582

2. In view of above, the undersigned is directed to accord Administrative Approval and Financial Sanction of **Rs 5,14,582 (Rupees five lakh fourteen thousand five hundred eighty two) only** in favour of **Principal, Dr B C Roy PGIPS** for executing the above mentioned work.

3. The fund is placed against the activity head, ICU Beds added at District Hospitals (ECRP-II) [RoP Code: S.2.4.2] [Tally Code: SA.2.4.2] under ECRP-II.

4. Financial Advisor, WBSH&FW Samiti will act as the Drawing & Disbursing Officer for releasing the fund.

5. Works will be taken up by the respective PWD offices and the fund may be sub-allotted accordingly.

6. The utilisation will be reflected by the institution in prescribed monthly FMR of ECRP-II, submitted to State FMG, NHM, WB.

7. Strict observance of all financial norms in respect of incurring expenditure out of the said fund must be followed and **data entry in NHM-PMS portal must be ensured by the concerned health facility.**

9. All concerned are being informed.


