2. The appointment of the candidates have been made on the recommendation of West Bengal Health Recruitment Board, Kolkata and will continue provisionally for 6 (six) months or until further orders with effect from their respective date of joining. If any declaration given or information furnished by the candidates are proved to be false subsequently, or in case of any adverse observation during verifications of their antecedents or if they are found to have willfully suppressed any material information, they will be liable to removal from service without assigning any reason and/or any such further action as the Government may deem necessary under the provision of law.

3. The pay of the Nursing faculty upon Appointment as Clinical Instructor shall be fixed in the revised pay structures (Rs. 35,800/- - Rs. 92,100/-) in Level-12 WBS (ROPA) 2019, Rules vide notification No. 5562-F dated 25.09.2019 of Finance Department (Audit Branch), Govt. of West Bengal .

4. The appointees are required to contribute compulsorily towards employees Group Insurance Scheme and General Provident Fund at such minimum rates as may be provided by the Govt. accordingly to rules


5. The appointees shall be governed by the terms and conditions of the State Govt. Service and all rules and orders of the State Govt. as are applicable to the State Govt. employees of similar category shall also apply mutatis and mutandis in respect of the candidates. The appointment carries with it the liability of service in any part of West Bengal or outside. The appointees are required to perform all such duties as may be assigned to them time to time besides the duties of the post in which they are or may be appointed. All subsequent orders issued by the State Govt. apropos service terms, conditions and pay etc, shall also apply towards them.

6. The appointees are hereby directed to report themselves for duty to the Head of the Institution concerned immediately and in any case not later than 4 (four) weeks from the date of issue of this order, failing which the offer of appointment to the West Bengal General Services (Nursing) Cadre shall stand automatically cancelled without further reference to them and vacancies will be filled up empanelled candidates as recommended by West Bengal Health Recruitment Board, Kolkata.

7. This appointment has been made as per the recommendations of the West Bengal Health Recruitment Board, Kolkata by the way of Direct Recruitment in accordance with the exemption permitted in terms of G.O. No. 4969-F(P) dated 20.06.2013 and in terms of the Recruitment Rules notified under G.O. No. HF/O/MERT/1561/GA(Ng)/1M-76/2012 dated 20.12.2013.
