**ORDER**

To combat probable 3<sup>rd</sup> surge of Covid-19 cases, it requires immediate provision of new Covid beds, augmentation of general and CCU/HDU beds at existing Covid hospitals, setting up of MGPS, laboratory, diagnostic facilities etc. M/S Webel Technology Ltd has submitted quotation for Mobile Device Management (MDM) vide their No. WTL/CEO/PSM/H&FW/Tab/MDM/Renewal/21-22/001 dated 28.12.2021 amounting Rs. 81,56,241/- {Rupees Eighty One Lakh Fifty Six Thousand Two Hundred Forty One} only (inclusive of Taxes) for 10,357 nos of Tablet computers for One year for use at Covid wards.

9. All concerned are being informed.


