ORDER

Administrative Approval was accorded for the scheme 'Construction of **12(twelve)** nos. of Non-GP Head Quarter Sub Centres at **Dakshin Dinajpur District**' at an estimated cost of **Rs.1,53,68,400/- (Rupees One crore fifty three lakh sixty eight thousand & four hundred)** only vide Order Nos. HFW/NHM-378/2017/095 dated 08.01.2018, HFW/NHM-378/2017/970 dated 06.03.2018 & HFW/NHM-378/2017/1336 dated 20.03.2018 at a unit rate of Rs.12,80,700.00 per Sub Centre.

2. Vide order No. HFW-27011/206/2018-NHM SEC-Dept. of H&FW/4321 dated 16.08.2018, Rs.76,84,200.00 only was released as first installment at a unit rate of Rs.6,40,350.00 per Sub Centre.

3. Chief Medical Officer of Health, Dakshin Dinajpur has now submitted the final requisition of fund for **04(four)** Sub Centres. In this connection, State Engineering Team has also done an Inspection visit to those Sub Centres. Hence, in continuation of the above mentioned order nos., an amount of **Rs.25,61,400.00 (Rupees Twenty five lakh sixty one thousand & four hundred)** only is hereby released in favour of District Health & Family Welfare Samiti, Dakshin Dinajpur District for subsequent placement of the same to the implementing agency.
