ORDER

Administrative approval and financial sanction was accorded for **Rs.38,72,556.00 (Rupees Thirty eight lakh seventy two thousand five hundred fifty six)** only in FY 2012-13 vide Memo No. HFW/NRHM/131/2010/1(Part)/762 dated 06.03.2013 towards an estimated cost for 'Construction of **04 (four)** nos. of **Non-GP Head Quarter Sub-Centres** in **Howrah District**' @Rs.9,68,139.00 per Sub-Centre. 50% of the sanctioned amount i.e. a fund of **Rs.19,36,278.00 (Rupees Nineteen lakh thirty six thousand two hundred seventy eight)** only was released vide the same order. Balance amount of **Rs.19,36,278.00** was also released from this end vide order No. HFW-27011/194/2018-NHM SEC-Dept. of H&FW/4506 dated 27.08.2018.

2. Now, Chief Medical Officer of Health, Howrah has submitted the requisition of additional fund of Rs.3,88,762.00 only for completion of those 04nos. of Non GPHQ Sub Centres. As reported by CMOH Howrah, construction work is completed in all these sites. Therefore, fund to be released is schematically mentioned in the table below :
