Apropos the captioned subject, administrative approval & financial sanction was accorded for the scheme 'Infrastructure Strengthening of Nora Suswasthya Kendra (HWC) under Baruipur Block of South 24 Pgs. District' at an estimated cost of Rs. 7,48,922.00 (Rupees Seven Lakh Forty Eight Thousand Nine Hundred & Twenty Two) only vide order no. HFW/NRHM-411/2019-2039 Dated. 14.06.2019. The work was entrusted to the Engineering wing of DPMU, South 24 Pgs. & fund placed with CMOH & Member Secretary, District Health & Family Welfare Samity, South 24 Pgs.
