ORDER

Administrative Approval was accorded for the scheme 'Construction of **02(two)** nos. of Non-GP Head Quarter Sub Centres at **Bishnupur Health District**' at an estimated cost of **Rs.25,61,400/- (Rupees Twenty five lakh sixty one thousand & four hundred)** only vide Order No. HFW/NHM-378/2017/1339 dated 20.03.2018 at a unit rate of Rs.12,80,700.00 per Sub Centre.

2. 50% fund for **Dibakarbati** Sub Centre under Indus block has already been released vide order No. HFW-27011/512/2018-NHM SEC-Dept. of H&FW/408 dated.31.01.2019.


