### ORDER

Administrative Approval was accorded for the scheme 'Construction of **07(seven)** nos. of Non-GP Head Quarter Sub Centres at **Malda District**' at an estimated cost of **Rs.89,64,900/- (Rupees Eighty nine lakh sixty four thousand & nine hundred)** only vide Order Nos. HFW/NHM-378/2017/101 dated 08.01.2018 & HFW/NHM-378/2017/1337 dated 20.03.2018 at a unit rate of Rs.12,80,700.00 per Sub Centre.

2. 50% fund for two Sub Centres (**Laxmipur** SC under Habibpur block & **Bhordighi** SC under Gazole block) has already been released vide Order No.HFW-27011/206/2018-NHM SEC-Dept.ofH&FW/5196 dated 09.10.2018.

3. Now, Chief Medical Officer of Health, Malda District has submitted the requisition of fund for these Sub Centres. Hence, in continuation of the above mentioned order no., an amount of **Rs.32,01,750.00 (Rupees Thirty two lakh one thousand seven hundred & fifty)** only is hereby released in favour of District Health & Family Welfare Samiti, Malda District for subsequent placement of the same to the implementing agency. 6. Senior Accounts Officer, National Health Mission will act as the Drawing & Disbursing Officer for the said purpose.


