### ORDER

Administrative Approval was accorded for the scheme 'Construction of **09(nine)** nos. of Non-GP Head Quarter Sub Centres at **Purulia District**' at an estimated cost of **Rs.1,15,26,300.00 (Rupees One crore fifteen lakh twenty six thousand & three hundred)** only vide Order Nos. HFW/NHM-378/2017/106 dated 08.01.2018, HFW/NHM-378/2017/981 dated 06.03.2018 and HFW/NHM-378/2017/1342 dated 20.03.2018.

2. 50% fund for Oldih Sub Centre has already been released vide Order No.HFW-27011/512/2018-NHM SEC-Dept.of H&FW/6260 Dt.20.12.2018.

3. Now, Chief Medical Officer of Health, Purulia District has submitted the requisition of fund for seven Sub Centres. Construction work has started in all seven sites. Hence, in continuation of the above mentioned order nos., an amount of **Rs.51,22,800.00 (Rupees Fifty one lakh twenty two thousand & eight hundred)** only is hereby released in favour of District Health & Family Welfare Samiti, Purulia District for subsequent placement of the same to the concerned Block Health & Family Welfare Samities. 
