ORDER

Administrative Approval and Financial Sanction was accorded for the scheme 'Construction of 02(two) nos. of Non-GP Head Quarter Sub Centers at Uttar Dinajpur district' amounting to Rs. 25,61,400/- (Rupees twenty five lakhs sixty one thousand and four hundred only) vide order No. HFW/NHM-378/2017/1335 dtd. 20.03.2018 .

1. Vide order No. HFW-27011/206/2018-NHM SEC-Dept. of H&FW/1352 dtd. 16.04.2019 , Rs. 6,40,350.00/- (Rupees six lakhs forty thousand three hundred and fifty only) was already released as 1st installment for the Nasratpur sub-centre of Raiganj block .
2. Chief Medical Officer of Health, Uttar Dinajpur District has now submitted the requisition of fund of Rs 6,40,350.00/- as per letter No. DHFWS/UD/RF-NGPHQSC/RNJ/6109/20 dtd. 15.10.2020 for Nasratpur Sub-Center at Raiganj Block . As per the analysis of the Work order as submitted from district's end , and the simultaneous 3% contingency charges , the balance fund amounting to Rs 6,39,069.00 (Rupees Six lakhs thirty nine thousand and sixty nine only) is hereby released in favour of District Health and Family Welfare Samiti, Uttar Dinajpur, in continuation to the above mentioned order nos., for subsequent placement of the same to the concerned agency.


