ORDER


Administrative Approval and Financial Sanction was accorded for the scheme 'Construction of 05(five) nos. of Non-GP Head Quarter Sub Centers at Darjeeling GTA district amounting to Rs. 70,55,000/- @ Rs 14,11,000/- per unit vide order No. HFW/NRHM-169/2009/(27)/789 dtd. 05.06.2017, and 'Construction of 03(three) nos. of Non-GP Head Quarter Sub Centers at Darjeeling GTA district amounting to Rs. 52,53,183/- @ Rs 17,51,061/- per unit vide order No. HFW/NHM-378/2017/2583 dtd. 18.05.2018.

- Vide order No. HFW/NHM-338/2020/1443 dated 02.09.2020 , an amount of Rs 28,22,000.00/- for 04(four) Sub-centres out of 05(five) sanctioned and vide order no. HFW-27011/206/2018-NHM SEC-Dept. of H&FW/3901 dtd. 23.07.2018, an amount of Rs. 26,26,591.50/- was already released as 1st installment of the sub-centres. **No fund has been released for Rajbari Sub-centre at Sukna block which is still a non-starter.**
- Secretary(DH&FWS, Darjeeling GTA) has now submitted the requisition of fund for **07(seven) completed Sub-centres**, namely – Singringtam(Takdah Rangali Rangliot block), Putung & Thurbo (Mirik block) , Mondakotee & Chamong (Sukhia Pokhri block) , Ringchingtong (Sukna block) and Jhalong (Gorubathan block) , as per letter No. **101/XX-7(A)/DH&FWS/GTA-21 dated 10.02.2021** . Hence, as per the analysis of the Work orders and corresponding 3% contingencies as submitted from district's end , the balance remaining fund of **07(seven) completed centres** amounting to **Rs 54,03,015.00 (Rupees Fifty four lakhs three thousand and fifteen only)** is hereby released in favour of Secretary(DH&FWS) , Darjeeling GTA , in continuation to the above mentioned order nos., for subsequent placement of the same to the concerned agency.


