ORDER

Administrative Approval and Financial Sanction is hereby accorded for the scheme 'Construction of 09(nine) nos. of Non-GP Head Quarter Sub Centre at North 24 Parganas Health District' at an estimated cost of Rs.1,15,26,300/- (Rupees One crore Fifteen lakhs Twenty Six thousand & three hundred only) vide order No. HFW/NHM-378/2017/1347 dated 20.03.2018 and HFW-27011/206/2018-NHM SEC- Dept. of H&FW/3905 dtd. 23.07.2018 , at a unit rate of Rs. 12,80,700.00 per Sub-Centre.

2. Chief Medical Officer of Health, North 24 Parganas Health District has now submitted the requisition of release of 50% of the sanctioned fund for **construction of Sub Centres at Sashadanga, Panchpota & Potlapara (Gaighata block), Chanda, Sutia & Bhamderkhola (Bongaon block), North 24 Parganas** as per Memo. No. CMOH/NPG/1114 dtd. 09.02.2021. In this connection, 50% fund of the sanctioned amount of the aforesaid 06(six) Sub-centres , amounting to **Rs 38,42,100.00(Rupees thirty eight lakh forty two thousand one hundred only)** is hereby released in favour of District Health and Family Welfare Samiti, North 24 Parganas District for subsequent placement of the same to the implementing agency.


