ORDER

Administrative Approval and Financial Sanction was accorded for the scheme 'Construction of 15(fifteen) nos. of Non-GP Head Quarter Sub Centers at Purba Medinipur district amounting to Rs. 1,92,10,500/- (Rupees one crore ninety two lakhs ten thousand and five hundred only) vide order No. HFW/NHM-378/2017/104 dtd. 08.01.2018, HFW/NHM-378/2017/979 dtd. 06.03.2018 & HFW/NHM-378/2017/1350 dtd. 20.03.2018.

- Vide order Nos. HFW-27011/206/2018-NHM SEC-Dept. of H&FW/4319 dtd. 20.12.2018 an amount of Rs. 96,05,250.00/- (Rupees ninety six lakhs five thousand and two hundred and fifty only) was already released as 1st installment for the 15(fifteen) sub-centres.
- Chief Medical Officer of Health, Purba Medinipur District has now submitted the requisition of fund of Rs 38,42,100.00/- for 06 completed Sub-centres, namely – Barbajitpur & Deulpota (Haldia block), Basukhal, Barbaria Paikbar, Chaksridha & Salika Damodarpur (Tamluk block) , as per letter Nos. DH&FWS/MID(E)/2109/2020-21 dtd. 14.12.2020 , DH&FWS/MID(E)/1728/2020-21 dtd. 04.11.2020 and Hal/BPMU/194/2020-21 dtd. 13.01.2021 . Hence, as per the analysis of the Work orders and corresponding 3% contingencies as submitted from district's end , the balance remaining fund of 06(six) completed centres amounting to Rs 33,87,716.00 (Rupees thirty three lakhs eighty seven thousand seven hundred and sixteen only) is hereby released in favour of District Health and Family Welfare Samiti, Purba Medinipur, in continuation to the above mentioned order nos., for subsequent placement of the same to the concerned agency.


