ORDER

Administrative Approval and Financial Sanction was accorded for the scheme 'Construction of 12(twelve) Non-GP Head Quarter Sub Centers at Dakhin Dinajpur district' amounting to Rs. 1,53,68,400/- (Rupees One crore fifty three lakhs sixty eight thousand and four hundred only) vide order Nos. HFW/NHM-378/2017/095 dtd. 08.01.2018, HFW/NHM-378/2017/970 dtd. 06.03.2018 & HFW/NHM-378/2017/1336 dtd. 20.03.2018.

- Vide order No. HFW-27011/206/2018-NHM SEC-Dept. of H&FW/4321 dtd. 16.08.2018 , Rs. 76,84,200.00/- (Rupees seventy six lakhs eighty four thousand and two hundred only) was already released as 1st installment for the 12(twelve) sub-centres.
- Chief Medical Officer of Health, Dakhin Dinajpur District has now submitted the requisition of fund of Rs 19,21,050.00/- as per letter No. DH&FWS/DD/ENGG/210 dtd. 06.02.2020, for 03(three) completed sub-centres namely- Thangapara & Pathanhat (Gangarampur block) and Shibpur(Banshihari block) . As per the analysis of the Work orders and corresponding 3% contingencies as submitted from district's end , the balance fund amounting to Rs 16,54,143.00 (Rupees Sixteen lakhs fifty four thousand one hundred and forty three only) is hereby released in favour of District Health and Family Welfare Samiti, Dakhin Dinajpur, in continuation to the above mentioned order nos., for subsequent placement of the same to the concerned agency.


