ORDER

Administrative Approval and Financial Sanction was accorded for the scheme 'Construction of 02(two) nos. of Non-GP Head Quarter Sub Centers at Hooghly district' amounting to Rs. 25,61,400/- (Rupees twenty five lakhs sixty one thousand and four hundred only) vide order No. HFW/NHM-378/2017/096 dated 08.01.2018 & HFW/NHM-378/2017/971 dated 06.03.2018 .

1. Vide order No. HFW-27011/206/2018-NHM SEC-Dept. of H&FW/105 dtd. 09.01.2019 , Rs. 19,21,050.00/- (Rupees nineteen lakhs twenty one thousand and fifty only) was already released as 1st installment for the 02(two) sub-centres namely- Bonhizli at Khanakul block and Nimdangi of Pursurah block .
2. Chief Medical Officer of Health, Hooghly District has now submitted the requisition of fund of Rs 6,40,350.00/- as per letter No. 3848 dtd. 19.08.2020 for Bonhizli Sub-Center at Khanakul-II Block . As per the analysis of the Utilization certificate from Zilla Parishad as submitted from district's end , the balance fund amounting to Rs 6,04,350.00 (Rupees Six lakhs four thousand three hundred and fifty only) is hereby released in favour of District Health and Family Welfare Samiti, Hooghly, in continuation to the above mentioned order nos., for subsequent placement of the same to the concerned agency.
