ORDER


Administrative Approval and Financial Sanction was accorded for the scheme 'Construction of 09(nine) nos. of Non-GP Head Quarter Sub Centers at Purulia district amounting to Rs. 1,15,26,300/- (Rupees one crore fifteen lakhs twenty six thousand and three hundred only) vide order No. HFW/NHM-378/2017/106 dtd. 08.01.2018, HFW/NHM-378/2017/981 dtd. 06.03.2018 & HFW/NHM-378/2017/1342 dtd. 20.03.2018.

- Vide order Nos. HFW-27011/512/2018-NHM SEC-Dept. of H&FW/6260 dtd. 20.12.2018 & HFW-27011/512/2018-NHM SEC-Dept. of H&FW/1566 dtd. 07.05.2019 Rs. 57,63,150.00/- (Rupees fifty seven lakhs sixty three thousand and one hundred and fifty only) was already released as 1st installment for the 09(nine) sub-centres.
- Chief Medical Officer of Health, Purulia District has now submitted the requisition of fund of Rs 38,42,100.00/- for 06 completed Sub-centres, namely – Pargela and Dhabani (Bandwan block), Sutabai (Kashipur block) , Shyampur (Joypur block) , Oldih (Jhalda-II block) and Bagbinda (Jhalda-I block) , as per letter No. 1040 dtd. 15.12.2020 . Now, amongst the 06 completed Sub-centres, Bagbinda of Jhalda-I has been done from Block funding. Hence, as per the analysis of the Work orders and corresponding 3% contingencies as submitted from district's end , the balance fund of 05(five) completed centres except Bagbinda Sub-centre(Jhalda-I), amounting to Rs 22,45,220.00 (Rupees twenty two lakhs forty five thousand two hundred and twenty only) is hereby released in favour of District Health and Family Welfare Samiti, Purulia, in continuation to the above mentioned order nos., for subsequent placement of the same to the concerned agency.


