ORDER

The Department of Health and Family Welfare, Govt of West Bengal has decided to construct permanent Covid Units at different health facilities under the ECRP-II fund for management of Covid-19 patients. Accordingly, Rs 307,76,54,905 was sanctioned to CMOHs for allotment to PWD for construction of 16 numbers of 100-bed Covid wards, 4 number of 50-bed Covid wards, 113 numbers of 20-bed Covid wards at different hospitals vide order No HFW-18033/1/2022-PHP/1279 dtd 7.4.2022. Also, 25% of the sanctioned amount was released to CMOHs as advances vide No HFW-18033/1/2022-PHP/Pt-I/2886 dtd 5.8.2022. Previously, fund of Rs. 3,10,50,406 has been released to the DH&FWS, Paschim Bardhaman against the said order. Now, CMOH, Paschim Bardhaman has placed requisition for placement of the balance fund.

In view of above, the undersigned is directed to release the balance fund of **Rs 9,31,51,219 (Rupees nine crore thirty one lakh fifty one thousand two hundred nineteen)** in favour of **Chief Medical Officer of Health, Paschim Bardhaman** for construction of 1 no of 100 bed and 2 nos of 20 bed Covid wards at Paschim Bardhaman (Annexed).

The fund of Rs. 9,31,51,219/- is placed against the activity head, Establishment of 20 Bedded Prefab Units at CHC Level (ECRP-II) [RoP Code: S.2.3.3] [Tally Code: SA.2.3.3] under ECRP-II.

Concerned CMOH is requested to subsequently release fund to the concerned **Executive Engineer(s), PWD.**

Works will be taken up by the respective PWD divisions. **The utilisation will be reflected by the institution in the prescribed monthly FMR of ECRP-II, submitted to State FMG, NHM, WB.**

Strict compliance with all financial norms in respect of incurring expenditure out of the said fund must be followed and **data entry in NHM-PMS portal must be ensured by the concerned facility.**

This is issued with the approval of Mission Director, NHM and Secretary of this Department.




