



**ORDER**

To combat probable 3rd surge of Covid-19 cases, this Department has entrusted the job of establishment of PSA plant at different SSH / DH / SDH level by setting up new PSA unit at 6 numbers facilities (Bishnupur SSH, Sagar RH, Lalbagh SDH, Uttarpara SGH, Gandhi Memorial Hospital-Nadia, Kharagpur SDH). The PSA plant will be under CSR donation by Google Path. Accordingly, estimate for civil / electrical and MGPS works of 06 (Six) nos. facilities have been prepared by WBMSCL engineers. The detail of Fund requirement is as below:

1. Civil Works =Rs. 2,17,30,235.00
  2. Electrical Works =Rs. 2,53,39,568.00
  3. MGPS Works =Rs. 27,70,772.00
- Total =Rs. 4,98,40,575.00

2. In view of above, the undersigned is directed to accord Administrative Approval and Financial Sanction of **Rs. 4,98,40,575 (Rupees four crore ninety eight lakh forty thousand five hundred seventy five) only** in favour of **West Bengal Medical Services Corporation Ltd** for civil, electrical and MGPS works in connection to installation of 6 PSA plants to be donated by PATH/Google.

8. This is issued with the approval of Secretary of this Department.


