



ORDER

To combat probable 3rd surge of Covid-19 cases, it requires immediate provision of new Covid beds, augmentation of general and CCU/HDU beds at existing Covid hospitals, setting up of MGPS, laboratory, diagnostic facilities etc. Rs 2,17,76,320 was sanctioned to WBSH&FW Samiti vide order No HFW-17014/6/2018-IT SEC-Dept. of H&FW/001 dtd 3.1.2022 for procurement of 340 Desktop, same nos of UPS and 68 laserjet Printers for strengthening 68 Tele Medicine Hubs. Further approval was accorded in favour of IT Cell earlier out of the ECRP-II fund for procurement of 970 Desktop, UPS and Web Cams for strengthening Tele Medicine Hubs.

2. In view of above, the undersigned is directed to accord Administrative Approval and Financial Sanction of Rs. 6,17,29,830 (Rupees six crore seventeen lakh twenty nine thousand eight hundred thirty) only in favour of **West Bengal State Health & Family Welfare Samiti** for payment of bills for procurement of 970 Desktop, same nos of UPS , Web cams for strengthening Tele Medicine Hubs across the State.

3. No fund will be released in favour of the WBSH&FW Samiti. The bills will be paid accordingly.

4. The fund is placed against the activity head, Hospital Management Information System (HMIS) (ECRP-II) [RoP Code: S.4.1] [Tally Code: SA.4.1] under ECRP-II.

5. Financial Advisor, WBSH&FW Samiti will act as the Drawing & Disbursing Officer for releasing the fund.

6. System Co-ordinator, IT Cell is requested to co-ordinate with FA, WBSH&FW Samiti regarding release of fund.

7. The utilisation certificate will be submitted by the organisation in format of GFR-12C to State FMG, NHM, WB.

8. Strict observance of all financial norms in respect of incurring expenditure out of the said fund must be followed and **data entry in NHM-PMS portal must be ensured by the concerned facility.**

9. This is issued with the approval of Mission Director, NHM & Secretary of this Department.


