Sir/Madam,

You are aware that a number of medical equipment, general equipment and furniture are soon to be delivered at Sub Centers, PHCs and BPHUs under rural components and UHWC and Polyclinics(UPHCs) under urban components through XV FC- Health Grant for FY 2021-22. All items are going to be supplied at site by the selected vendors.

In this regard, kindly be informed that Deputy CMOH-1 has been designated as nodal officer for seamless delivery and installation of all such items at the assigned healthcare facilities mentioned above. He/She should co-ordinate with concerned local authorities during supply and installation, to ensure that no delay is caused during supply, on account of lack of co-ordination or miscommunication at any level. BMEs posted under DPMUs will assist him/her till installation/commissioning has been completed. Please note that WBMSCL is the executing authority for procurement of above category of items. Deputy CMOH-1 shall remain the Nodal officer for all procurements under XV FC-HG in future also, along with being the nodal officer for all infrastructure development through RIDF-XXVII/XXVIII, XV FC-HG and NHM etc.
