ORDER

Administrative Approval is hereby accorded for the scheme 'Infrastructure Strengthening of Primary Health Centres to Suswasthya Kendras/ Health & Wellness Centres (HWC)' at Jalpaiguri district at an estimated cost of Rs.2,66,81,401.00 (Rupees Two crore sixty six lakh eighty one thousand four hundred & one) only for 23 (twenty three) PHCs.

2. The repair & renovation works of Suswasthya Kendras will have to be done at these 23 PHCs selected by this Department. The cost for repair and renovation works shall not exceed the vetted amount on the basis of revised PWD (WB) SoR and introduction of GST from 1st November, 2017 with corrigenda & addenda 1st (08/01/2018), 2nd (18/04/2018) & 3rd (04/06/2018) (Annexure-I).

4. The quotation has to be invited within 20.02.2019 on short notice considering the urgency in executing the work.
5. The implementing agency for upgradation of PHCs to Su-Swasthya Kendras (HWC) will be Engineering Wing, DPMU, Jalpaiguri.

6. The released amount may be treated as a pool fund for the said activity. No price escalation will be allowed further to implement the work. No other works other than the scheme sanctioned are to be implemented / taken up against the approval accorded.

8. On receiving requisition, fund will be released in favour of District Health & Family Welfare Samity, Jalpaiguri for subsequent placement of the same to the implementing agency and will book this expenditure in the FMR.
9. State Inspection Team from SPMU will make periodical on-site visits to review the progress of work and check the quality of work being implemented. No payments will be made until the clearance on the quality of the work has been permitted from this end.
10. The charge is debitible from the fund of NHM Flexi-Pool 2018-19 under the FMR Head of Account 'Infrastructure Strengthening of PHCs to Health & Wellness Centres (NRHM) [Tally Code –B.04.01.07.02].
11. Senior Accounts Officer, National Health Mission will act as the Drawing & Disbursing Officer for the said purpose.
12. This issues with the approval of the Mission Director, NHM & Secretary, Health & Family Welfare Department, Government of West Bengal.
13. Any change in the name of the site notified above should immediately be informed to SPMU for necessary approval from this end and updation in the HWC portal thereafter.
