ORDER

Administrative approval & financial sanction is hereby accorded for Rs. 19,63,694/- (Rupees Nineteen Lakh Sixty Three Thousand Six Hundred & Ninety Four) for salary support of 5 MOs and 4 ANMs under the head "2nd ANMs-RCH(NRHM)" [Tally Code : B.30.01.01] of 7 ULBs of the districts of West Bengal, having population between 30,000 and 50,000 for the period of 01.04.2018 to 31.03.2019. These ULBs are not included under NUHM.

The amount of Rs. 15,12,000/- (Rupees Fifteen Lakh Twelve Thousands only) is hereby released for salary support of 5 MOs and Rs. 3,85,094/- (Rupees Three Lakh Eighty Five Thousands Ninety Four only) is hereby released for salary support of 4 ANMs of the selected ULBs for the period of 01.04.2018 to 31.03.2019. Puja Bonus for the FY 2016-17 and 2017-18 for these 5 MOs and 4 ANMs are Rs. 32400/- and Rs. 34,200/- respectively.

Total approval, Rs. 19,63,694/- (Rupees Nineteen Lakh Sixty Three Thousand Six Hundred & Ninety Four) is being released in favour of SUDA as per the list in Annexure-I.

Senior Accounts Officer, NHM will act as Drawing and Disbursing Officer for the purpose.

The expenditure will be incurred as per the annexure abiding by the standard norms of the NHM.

Necessary Utilization Certificate in this regard shall be submitted in due course under proper head of account.


