**ORDER**

Administrative Approval was accorded for the scheme 'Construction of **01(one)** no. of Non-GP Head Quarter Sub Centres at **Jhalong** under Gorubathan block at **Darjeeling (GTA) District**' at an estimated cost of **Rs.17,51,061/- (Rupees Seventeen lakh fifty one thousand & sixty one)** only vide Order No. HFW/NHM-378/2017/2583 dated 18.05.2018. Gorubathan block now is under the jurisdiction of **Kalimpong** District.

2. Now, Secretary, DH&FWS, Darjeeling (GTA) has submitted the requisition of fund for the Sub Centre. Hence, in continuation of the above mentioned order no., an amount of **Rs.8,75,530.00 (Rupees Eight lakh seventy five thousand five hundred & thirty)** only is hereby released in favour of District Health & Family Welfare Samiti, Darjeeling (GTA) District for subsequent placement of the same to Kalimpong District. Kalimpong District authority will place the fund to implementing agency for the said work. Details is as follows –

6. Engineer-in-Charge, SPMU will make periodical on-site visits to review the progress of work and check the quality of work being implemented.
