ORDER

Administrative approval and financial sanction was accorded for the scheme 'Setting up of Common Collection Site at Nakashipara & Karimpur Rural Hospital of Nadia District' at an aggregated cost of Rs. 13,60,000.00 (Rupees Thirteen Lakh & Sixty Thousand) only vide order No. HHM/1H-49-2015/Part/(4532/A)/4140 Dated. 05.01.2017 & subsequently, entire fund was released in favour of District Health & Family Welfare Samity, Nadia for implementation of the said schemes.

2. Later on, it was reported by CMOH, Nadia that due to non-completion of the tender process in the prescribed time, the schemes were dropped & hence, the awarded amount of Rs. 13,60,000.00 was refunded to State Programme Management Unit, National Health Mission.

3. Now, CMOH, Nadia has informed that the tender process has been completed & execution of the schemes will be commenced soon & requested to release the fund of Rs. 13,60,000.00. Hence, in continuation of the abovementioned order no. an amount of Rs. 13,60,000.00 (Rupees Thirteen Lakh & Sixty Thousand) only is hereby released & placed in favour of District Health & Family Welfare Samity, Nadia for execution of the schemes.
