**NOTIFICATION**

No. 53/HF/O/GA(Ng)/1N-132/2017 dated 07.06.2019, in exercise of the powers conferred by the proviso to article 309 of the constitution of India, the Governor is hereby pleased to make the following rules regulating recruitment to the post of Warden in Nursing Training Institutions under Directorate of Health Services, Department of Health & Family Welfare, West Bengal namely :-

**RULES**

1. Short title commencement :-
  - (i) These rules may be called the West Bengal Warden (recruitment) Rules, 2018.
  - (ii) They shall come into force at once.
2. Definition :-

In these rules unless there is anything repugnant in the subject or context, ----

  - (i) 'appointment on permanent basis' means substantive appointment with confirmation;
  - (ii) 'Government' means the Department of Health & Family Welfare, Government of West Bengal;
  - (iii) 'temporary service' means service beginning on the date of joining under Government till the date of appointment on permanent basis.
3. The name of the post(s) :-

Warden (for College of Nursing and Nursing Training School).
4. Classification of post :-

Group – C (Non-Gazetted).
5. The method of recruitment :-

By direct recruitment through West Bengal Health Recruitment Board.
6. Age limit :-

40 (Forty) years (in terms of Notification No. 875-F(P) dated 13.02.2017 of Finance (Audit) Department). Upper age limit is relaxable by 5(five) years in case of Scheduled Castes / Scheduled Tribes / Physically Handicapped candidates and 3(Three) years relaxable in case of Other Backward Classes-A and Other Backward Classes-B candidates.
7. Educational Qualification :-

Minimum required qualification Madhyamik or equivalent.
8. Scale of Pay:-

P.B.-2 (Rs. 5,400 – 25,200/-) with Grade Pay Rs. 2,600/- as per WBS (ROP&A) Rules, 2009.
9. Interpretation :-

If any question arises relating to the interpretation of these rules, it shall be referred to Department of Health & Family Welfare, Government of West Bengal.
