



ORDER

To combat surge of Covid-19 cases, it requires immediate provision of new Covid beds, augmentation of general and CCU/HDU beds at existing Covid hospitals, setting up of MGPS, laboratory, diagnostic facilities etc. All DMs and Principal of MCHs were empowered to take up necessary civil/electrical and constructional works in terms of order No. 133-HS(MS)/2(6)/HFW-43011(11)/85/2021 dated 28-5-2021. Accordingly, CMOH, Purba Bardhaman has informed that old batteries for existing 2 nos 6KVA on-Line UPS at HDU and SNSU at Kalna SDH, Kalna, Purba Bardhaman were replaced in exigency basis for the benefit of public service. Concerned CMOH has also placed fund demand of Rs 9,19,925 and requested for approval.

2. In view of above, the undersigned is directed to accord post-facto Administrative Approval and Financial Sanction of **Rs. 9,19,925 (Rupees nine lakh nineteen thousand nine hundred twenty five) only** in favour of **Chief Medical Officer of Health, Purba Bardhaman** for payment to executing agency/PWD division for replacement of old batteries for existing 2 nos 6KVA on-Line UPS at HDU and SNSU at Kalna SDH.

3. The fund is placed against the activity head, ICU Beds added at other Public Healthcare Facilities (ECRP-II) [RoP Code: S.2.4.5] [Tally Code: SA.2.4.5] under ECRP-II.

4. Financial Advisor, WBSH&FW Samiti will act as the Drawing & Disbursing Officer for releasing the fund and he is requested to release the fund to **Purba Bardhaman District Health & Family Welfare Samiti**.

5. Chief Medical Officer of Health, **Purba Bardhaman** will sub-allot the fund to the concerned agency/service providers by strict observance of existing financial norms.

6. The utilisation will be reflected by the institution in prescribed monthly FMR of ECRP-II, submitted to State FMG, NHM, WB.

7. Strict observance of all financial norms in respect of incurring expenditure out of the said fund must be followed and **data entry in NHM-PMS portal must be ensured by the concerned facility.**

8. This is issued with the approval of Mission Director, NHM & Secretary, Health & Family Welfare Department.


