



ORDER

The Department of Health and Family Welfare, Govt of West Bengal has decided to construct permanent Covid Units at different health facilities under the ECRP-II fund for management of Covid-19 patients. Accordingly, fund of Rs 431.756 Crore (Rs 307,76,54,905 + Rs 3,94,90,590 + Rs 119,84,98,423) has already been released for allotment to PWD, GTA and WBMSCL previously for construction of 24 numbers of 100-bed Covid wards, 6 number of 50-bed Covid wards ,118 numbers of 20-bed Covid wards and vertical extension of one Covid ward at different hospitals

Now, as desired by this Department, PWD has submitted estimate for construction of a 20-bed Covid ward at Keshpur BPHC.

In view of the above, the undersigned is directed to accord Administrative Approval and Financial Sanction of **Rs. 87,75,713 (Rupees eighty seven lakh seventy five thousand seven hundred thirteen)** in favour of **CMOH, Paschim Medinipur** for construction of 20-bed Covid building at Keshpur BPHC.

The fund is placed against the activity head, **Establishment of 20 Bedded Prefab Units at CHC Level (ECRP-II) [RoP Code: S.2.3.3] [Tally Code: SA.2.3.3]** under ECRP-II.

Concerned CMOH is requested to release fund to the concerned **Executive Engineer, PWD** after receiving requirement of fund for the approved works.

Financial Advisor, WBSH&FW Samiti will act as the Drawing & Disbursing Officer for releasing the fund. **25% of the sanctioned amount shall be placed as the mobilization advance with the CMOH, Paschim Medinipur. Next 25% shall be claimed on submission of the UC for the previous allotment.**

Works will be taken up by the respective PWD divisions. **The utilisation will be reflected by the institution in the prescribed monthly FMR of ECRP-II, submitted to State FMG, NHM, WB.**

Strict compliance with all financial norms in respect of incurring expenditure out of the said fund must be followed and **data entry in NHM-PMS portal must be ensured by the concerned facility.**


