ORDER

To combat probable 3rd surge of Covid-19 cases, it requires immediate provision of new Covid beds, augmentation of general and CCU/HDU beds at existing Covid hospitals, setting up of MGPS, laboratory, diagnostic facilities etc. Thus, PWD and other concerned agencies have been requested to take up requisite civil and electrical works at the concerned health facilities. Accordingly, estimate has been received from Chief Medical Officer of health, North 24 Pgs for following work with request to issue AAFS:

2. In view of above, the undersigned is directed to accord Administrative Approval and Financial Sanction of **Rs. 19,45,880 (Rupees nineteen lakh forty five thousand eight hundred eighty) only** in favour of **West Bengal Medical Services Corporation Ltd** for executing the above mentioned works.


