- iii. Non-deviation of allotted fund from approved scheme;
- iv. There will be no deviations-technical or otherwise from the approved norms; and,
- v. Submission of utilization certificate of the fund allotted before release of further amount.

This order is issued in exercise of power delegated under Finance Department Memo. No. 1872-FB, dated 26/03/2018 and vide U.O. No. 341, dated 05/06/2018 of Financial Advisor Branch, Health & Family Welfare Department.

All concerned are being informed accordingly.






