**MEMORANDUM**

Administrative approval of Rs.6.20,800/- was given to Chief Engineer, PWD (Electrical) vide this Department's Order No. 2112-(Sanction)-HF/P/P&B/PHP/6M-19/2011 dated 19/01/2017 for renovation of electrical works at Male & Female Wards of Institute of Mental Care, Purulia and accordingly Rs.1.00 lakh was released which was not utilized in the financial year 2016-17. Later, an amount of Rs.4,11,753/- was released vide Memo No. 2206-(Sanction)-HF/P/P&B/PHP/6M-19/2011 dated 13th March, 2018 in the Financial year 2017-18. Now, the Executive Engineer, PWD, Purulia Electrical Division has requested to release Rs.2,09,047/- in the financial year 2017-18 vide his Memo No 89/1(5)/PED/2018, Dated 18.04.2018.

The Governor is pleased to accord sanction of Rs. 2,09,047/- (Rupees Two lakh nine thousand and forty-seven) only during this current financial year 2018-19 for the works as stated above and place the fund at the disposal of Chief Engineer(Electrical-1), P.W.D., Govt. of West Bengal, Writers' Buildings, Kolkata- 700 001 and he is authorized to sub-allot the Fund to the Executive Engineer, Purulia Electrical Division, P.W.D.


The charge is debitable to the Head of Account "24-HF-4210-01-800-Other Expenditure-State Development Schemes-021- Mental Hospitals(HF)- 53- Major Works/ Land & Buildings" in the State Budget during the current financial year 2018-19.

The fund is sanctioned subject to the following conditions :-

- i) Strict observance of all relevant financial rules and regulations
- ii) Timely completion of the work to avoid escalation of cost
- iii) Non-deviation of allotted fund from approved schemes
- iv) Submission of Utilization Certificate of the allotted fund and statement of expenditure to this Department in due course.

This order is issued in exercise of power delegated under Finance Department Memo. No. 1872-FB, dated 26/03/2018 and vide U.O. No. 152, dated 11/05/2018 of Financial Advisor Branch, Health & Family Welfare Department.


