Notification

A Government Order No. HF/O/PHP/322/O-23/98 dated 20.05.2002 was issued for the formation of District Health & Family Welfare Samiti in every District with a view to facilitate the integration and co-ordination of all Public Health activities in the District. In view of the special status of the erstwhile Darjeeling Gorkha Autonomous Hill Council (DGAHC), a separate Samiti was set up for the DGAHC areas and, another Samiti for Siliguri vide order no. HF/O/PHP/553/O/98 dated 20th August 2002.

Now with the formation of Kalimpong District vide Gazette Notification No. 35 PAR (AR)/O/2R/16 dated 7th February 2017 with effect from 14th day of February 2017, a separate Samiti needs to be formed for Kalimpong District. The objectives for the formation of the Samiti will be the same as stated in Memo No. HF/SPSRC/112/2013/384 dated 29.09.2014.
