**NOTIFICATION**

The Governor has been pleased to allow the following Medical Officers of the West Bengal Health Service as mentioned who have completed 16 (sixteen) years' continuous and satisfactory service from the date of their regular appointment in the said service without any promotion and with one advancement to next higher scale of pay and now enjoying the scale of pay of Rs.10,000 – 15,525/- (Scale No.17 under ROPA, 1998) and its corresponding revised Scale of Pay Band-4A, Rs.15,600-42,000/-+Grade Pay of Rs.6,600/- taken together, to move to the next higher scale of pay of Rs.12,000 – 375 – 18,000/- (Scale No.18 under ROPA, 1998) and its corresponding revised Scale of Pay, Band-4B, Rs.28,000-52,000/-+Grade Pay of Rs.7,600/- under W.B.S.(ROPA) Rules, 2009, with effect from the date(s) as mentioned against each and to allow them to continue in their present places of posting until further orders.

2. On their entitlement to the higher scale of pay of Rs.12,000 – 375 – 18,000/- (Scale No.18 under ROPA, 1998) and its corresponding revised Scale of Pay, Band-4B, Rs.28,000-52,000/-+Grade Pay of Rs. 7,600/- under W.B.S.(ROPA) Rules, 2009, the pay of the concerned Medical Officers shall be fixed in terms of Finance Department's Memo. No.3015 – F, dt.13.03.2001. Besides, the said Medical Officers would also be entitled to the pay and allowances as admissible to them in terms of rules & orders of the State Government in force from time to time.

3. While giving the effect to the above benefits to the concerned Medical Officers the date of their joining in the West Bengal Health Services on regular basis, **AND NOT ON ADHOC BASIS**, as also continuity of the service should strictly be verified by the head of the institution vis-à-vis the entries in their Service Books. Discrepancies, if any subsequently been found, shall immediately be brought to the notice of this Department for taking further necessary action prior to giving effect to this order in respect of the said concerned Medical Officers.
