A	141	w.e.f 01.04.2018 to 30.04.2018 or till finalization of the next tender whichever is earlier
B	118	w.e.f 01.04.2018 to 30.06.2018 or till finalization of the next tender whichever is earlier
C	84	w.e.f 01.04.2018 to 30.06.2018 or till finalization of the next tender whichever is earlier

Extension of validity of rates of the items may be made with the following conditions:


- i. The tenure of contract of any existing vendor defaulting in supply for more than 3(three) months in the current financial year, or supplying sub-standard item(s) or violating any other material condition of the Agreement would not be extended.
- ii. In such cases where the existing vendor is unwilling to accept the extension or the tenure or contract is not extended in terms of (i) above, it should be explored whether the L2 bidder in the item is agreeable to supply the item at the rate quoted by the L1 bidder, and if so, a formal proposal in the matter be sent to Department for approval.

- iii. In cases where no alternative vendor would be available, a proposal along with supporting documents should be sent to the Department recommending procurement of such items through the nearest Fair Price Medicine Shop, or through local purchase otherwise, after observance of the required formalities.
