**Sub: Administrative Approval for Procurement of MOL BIO machines for commencing H1N1 testing Laboratories.**

Government has decided to set-up H1N1 testing laboratories in the following four Medical College and Hospitals across the State:

1. North Bengal Medical College and Hospital
2. Burdwan Medical College and Hospital
3. Midnapur Medical College and Hospital
4. Murshidabad Medical College & Hospital.

DHS & E.O. Secretary has recommended for installation of MOL BIO machines at these testing Laboratories.

In view of above, the undersigned is directed by order of the Governor to say that the Governor has been pleased to accord Administrative Approval in respect of the expenditure required for procurement and installation of these machines for intensive surveillance and diagnostic of H1N1 cases in the State from the head of Account "4210-06-200-Other Programme-SP-(Annual Plan+12<sup>th</sup> Plan)-003-Improvement of Public Health Laboratories (HF)-52-Machinery and Equipment/Tools & Plans Major Works" in the Financial Year 2018-19.

Managing Director, West Bengal Medical Services Corporation Limited (WBMSCL) is requested to kindly inform the rates for procurement of the MOL BIO machines along with consumables.

Joint DHS (PH&CD), H&FW Department, West Bengal, will provide specifications of the machines to Managing Director, West Bengal Medical Services Corporation Limited (WBMSCL).

Assistant Secretary & DDO of this Department will act as DDO in respect of the fund and he is requested to make subsequent payment accordingly.
