Sub.: Contractual engagement of Medical Technologist(Lab.) & Medical Technologist(Radio-Diagnostics) at different Medical College & Hospitals.

In continuation this Department Memo No. HF/O/MA/333/2M-09/2009 dated 21.01.2010 and any subsequent G.O. issued in this respect from this end, the undersigned is directed to request him to complete the necessary formalities towards contractual engagement in the posts of “Medical Technologist(Laboratory)” and “Medical Technologist(Radio-Diagnostics)” & also in other categories of M.T. mentioned in memo no. HF/O/MA/333/..... dt, 21.01.2010 up to 50% of the existing vacancies(total sanctioned post to be declared) of Hospital/Institute, as per existing recruitment rules with the upper age limit taken as 37 year and send the names of the selected personnel along with all the relevant original documents to this end for issuance of final orders in this regard.

2. The contractual engagements mentioned above will be initially for a period upto 31.03.2011, on till regular basis appointment in these posts, whichever is earlier.
3. The monthly contractual remuneration will be the initial Basic Pay, i.e., Band Pay + Grade Pay + usual allowances as admissible to regular Medical Technologists working under this Government.
4. The selection of the candidates should be made on the basis of test/interview in a transparent manner following open advertisement in daily newspapers.
5. The Medical Superintendent-cum-Vice Principal is requested to process the matter in consultation with Principal/Director of the Institute.
6. The Medical Superintendent-cum-Vice Principal is also requested to see that the number of personnel to be engaged should not cross the stipulated limit of 50% of the existing vacancies & the existing vacancy of each category along with the sanctioned strength should be mentioned.
7. This is issued under due concurrence of Finance Department vide their U.O. No.4357 Gr. ‘P’(Services) dated 24.12.2009 read with their U.O. No.3425 Gr. ‘P’(Service) dated 22.09.2010.
