The agreement will be prepared in non judicial stamp paper of Rs. 100/- by the private partners for running the Fair Price Medicine Shops. It is also to be noted that the performance security has to be renewed in form of Bank Guarantee to be furnished by the private partners while executing the agreement. The performance security is to be executed with the concerned bank in non judicial stamp paper of Rs. 50/- . The duly completed bank guarantee needs to be provided as scheduled 3 of the agreement.

The possession Certificate has to be renewed as provided in schedule 2 of the agreement format attached in Annexure –I.
