3. X-ray Report of Chest with plate from a competent radiologist.
4. Three recent passport size photographs.
5. One address proof with photo I.D [Aadhar card or Voter card] - both original and self attested photocopy.
6. Admit card of PSC examination - both original and self attested photocopy.
7. Any other relevant medical document/s.
