2nd Manual UG Dental Counseling West Bengal 2017

Few Seats in BDS are left vacant after 3rd round manual counseling as some candidates shifted to MBBS courses under management quota.

Some seats are left vacant as even after being allotted candidates did not report to the allotted institutes by the stipulated time.

Some BDS seats have also reverted back to state quota from all India quota.

In order to fill up such vacant UG Dental seats, a second manual round of counseling will be held on 1st September 2017 at MEDICAL COLLEGE KOLKATA at 88 College Street, Kolkata 700073 from 9 A.M. onwards.

The rules for participation in this 2nd manual UG Dental counseling round are laid down as below:-

1. Only those eligible candidates who registered and participated in 3rd round manual counseling held at MEDICAL COLLEGE KOLKATA will be eligible for these afore mentioned seats. **The list of eligible candidates for 2nd manual UG dental counseling will be published in departmental website by 6 pm of 30.08.2017 along with the vacancies.**
2. The eligible candidates for manual round who registered on the day of first manual counseling but who were not called as seats were exhausted will also be eligible.
3. The eligible candidates who participated in first manual round and were allotted a seat but did not take admission after such first manual counseling will not be eligible to participate.
4. An online facility for '**Interest in Participation**' to second manual round of UG Dental counseling for candidates will be available from **30th August 2017, 8 PM to 31st August 2017 8PM** at <http://wbuhs.ac.in/bds2017>
5. Interested candidates have to register online and bring a printed copy of this '**Interest in Participation**' for second manual round of UG Dental counseling.
6. Counseling will be held as per procedure followed for first ST->then SC->then Unreserved category seats (including PVT management quota seats).

7. Unreserved seats will also include PVT management quota seats and upgrade between UR and PVT seats will be allowed.
8. As there is no OBC A or OBC B vacancies so such candidates can participate along with UR candidates and will be called as per combined merit list only.
9. The candidates who fail to show Interest in participation online will also get chance to register on spot but may have to wait in queue. This interest in participation slip will help candidates to avert such long waiting and queue and direct entry to the counseling venue.
10. The counseling will be conducted in the UNB hall opposite to the Principal's office (administrative block) while candidates will have to wait/report initially to the ACADEMY building adjacent to the UNB hall.
11. Admittance to waiting area in ACADEMY hall for candidates coming with printed copy of interest in participation **will close by 11 am**. No such candidate reporting after 11 am will be entertained. Similarly spot registration for candidates **will close at 11 am** however if any candidate manages to attend the venue and presents in the queue for spot registration **by 11 am**, will be allowed. Such candidate/s will be identified with spot tokens. The candidates who come for spot registration will have to fill up the form for INTEREST IN PARTICIPATION on spot.
12. **Non eligible candidates for 2nd manual UG Dental counseling are not allowed in the premises of counseling.**
13. The candidates have to appear along with all the original documents and one self ID card as mentioned in the notice for the first manual mop up published on 25.08.2017 bearing memo No. HF/O/MERT/1237/2M-01/17 (for those eligible candidates who were not allotted any seat till now).
14. The candidate who are at present allotted and admitted they have to bring one self ID card and admission letter and document deposit receipt from the concerned college as mentioned in the notice for the first manual mop up published on 25.08.2017 bearing memo No. HF/O/MERT/1237/2M-01/17.
