

However, the Bidders are required to produce the original hardcopy of the clarifications/additional documents submitted as per the requirement of the TIA as when required.

The clarifications/additional documents shall be submitted as per the format and criteria as mentioned in the RFP documents including all the corrigendum's issued from time to time duly signed by the authorized signatory of the Bidder.
