Dear Sir/Ma'am,


Reference to the above, notice was issued for granting extension of the renewal agreement from time to time for FPMS after completion of a term of 4+4 years of initial agreement period. It has been seen that the extension period of 71 FPMS (**List attached in Annexure I**) are expiring between September 2021 till February 2022.

Approval is hereby granted for further extension of the existing agreement of the 71 FPMS as per annexure I from the date of expiry of the present renewal/ extension order till 31st March, 2022 on the following conditions; -

1. For purpose of calculation of the expiry date of the current renewal agreement/extension addendum, the effective date of the renewal agreement as mentioned in the departmental renewal/extension approval order has to be considered.
2. The hospital authority and the private partner will sign an addendum to this effect as per the format given in Annexure II.
3. All other terms and conditions of the renewal agreement will remain unchanged until further orders. All dues including rent and electricity has to be cleared till date by the private partner before signing of the addendum.
4. The addendum will be prepared in non-judicial stamp paper of Rs. 100/- by the private partners for running the Fair Price Medicine Shops. The performance security has to be extended with the concerned bank in non-judicial stamp paper of Rs. 50/-
5. Before signing the addendum, the hospital authority will verify all the documents related to renewal agreement and instruct the private partner to extend the validity of existing BG upto 31st August 2022.
