**Sub : Notice for payment of pending dues in respect to Digital X Ray Unit at Canning SDH**

Reference: - Your Proposal for discontinuation / Non Renewal of PPP agreement at Canning DH for Digital X Ray Services from your organization and subsequent recommendation by CMOH, South 24 Parganas.

This is regarding the Digital X Ray Services under O&M PPP model at canning SDH, where your organization was the selected H-1 bidder. The agreement has already expired on 31.03.2020 and unit is since then running without any valid agreement.

Whereas, based on several prayers received from hospital authority regarding nonpayment of dues from your end, hearing was held under the chair of Director of Health Services on 03/12/2019 and necessary instructions issued to clear all dues immediately as per agreement norms;

And whereas based on the fact that existing agreement has long expired, the PPP CELL of the department sought for final recommendation of CMOH South 24 Parganas regarding future action plan for functioning of the unit;

And whereas, report has been received from CMOH South 24 Parganas, that your organization desires to discontinue services at Canning SDH and a hearing was conducted under CMOH South 24 Parganas on 19/08/2021 on the said matter;

And whereas, CMOH South 24 Parganas have reported that total dues on account of concession fees payable to hospital as per terms and conditions of agreement till 31<sup>st</sup> July is Rs.62,40,240/- and total dues on account of electricity bills payable by your organization till 31<sup>st</sup> July is Rs.12,80,000/- taking total due amount to Rs.75,20,240/-;

And whereas after deduction of the amount payable by hospital till July 2021, on account of service charge, the net amount payable to hospital till July '2021 is Rs.45,58,460/- as reported by hospital authority.

And whereas the Bank guarantee, of Rs.5,42,000/- has already expired and same was not renewed by your organization.


And whereas, as per agreement terms and conditions, exit clause is applicable only when all dues payable to the hospital is deposited by your organization at current date.

Now as decided by the department, your prayer for payment of the due amount in post dated cheques in installment is not acceptable as per financial rules of the department. Accordingly you are hereby directed to deposit the entire amount due on account of concession fees and electricity to the RKS of Canning SDH, after settlement of final calculations with hospital authority within 15 days of receiving this letter. Hospital

authority will also immediately pay all the dues on account of service charges to your end. Please provide a status report within next 15 days.

If the same is not complied within the stipulated time mentioned in this letter, the dues will be recovered along with applicable interest as per approved FD rates. This amount will be recovered from the payable amount on account of service charges, for the other four Digital X Ray Units run by your organization under current agreement at Diamond Harbour GMCH, Nadia DH, Sambhu Nath Pandit hospital annex of IPGMER, SSKM and R. Ahmed Dental College Hospital.
