Sub : Delay in operationalization of FPMS at Madhabnagar Pathar Pratima Rural Hospital, Diamond Harbour HD.

Whereas, the department had floated e-tender vide Memo No HFW-14015 (11)/1/2020 SPSRC SEC Dept of H&FW/PPP/1338 dated 23/09/2020 and further dated 24/09/2020 (2nd Call) to establish Fair Price Medicine Shop at Madhabnagar, Patharpratima RH;

And whereas, on basis of your selection as H-1 bidder, with offer of 66% discount on MRP, your organization was issued offer letter dated 05/02/2021.

And whereas on acceptance of the offer letter dated 06/02/2021, Award of Contract "AOC" was issued by department vide Memo No. HFW-14015(11)/1/2020 – SPSRC SEC Dept of H&FW/PPP/1425 Dated 08/02/2021;

And whereas, your organization vide letter UMD/20-21/0108 Dated 19/02/2021 agreed to deposit the performance security amount of Rs.3,00,000/- within 15 days and take site handover and sign agreement for establishment of FPMS at Mahabnagar, Patharpratima RH;

And whereas the PPP Cell of the department held a convergence meeting on 18th Feb 2021, where all the hospital authorities were communicated about your selection and further process to be followed for implementation of the project;

And whereas, even after repeated reminder and mails by PPP Cell of department and hospital authorities, your organization has neither deposited the performance security nor signed the agreement copy with the hospital authority without any proper reason;

And whereas such delay on your end has caused immense damage to the important project and the essential service the patients of the area were supposed to receive had the FPMS been opened timely;

And whereas, Fair Price Medicine Shop being a flagship and prestigious project of the department, has suffered irresponsible damage from such delay and unprofessional attitude from your organization;

Under such circumstances, the department has decided to issue this letter to your organization, asking you to site reasons for such unjustified delay in starting essential and emergency service for which you were selected through tender process and your organization has accepted the Award of Contract and committed in writing to start services timely.

You are also requested to provide reasons as to why your organization should not be black listed and debarred from participation of any future Tender of similar nature floated by the department, because of such unprofessional attitude in such an important Government Project.

Please send your reply and your organization final stand on the above project within 7 days of receipt of this letter.




