This is in relation to the renewal of Fair Price Medicine Shops at different Government Hospitals in West Bengal running in PPP model as per departmental notifications issued from time to time, where the initial agreement was signed between Hospital authorities and concerned private partners selected through tender process.

Approval is hereby granted for first renewal of agreement for a period of 4 years of the following FPMS, effective from the date as per the table below:

Fresh **Renewal Agreement** in standard format as provided in annexure –I may be signed between respective Hospital authorities and the concerned private organization effective from the date for a period of 4 years as mentioned in the table above. All terms and condition of the agreement will apply for the entire period as mentioned above. **All dues including rent and electricity has to be cleared till date by the PPP partner before signing of the renewal agreement.**

Superintendent will sign agreement with freshly calculated rent on present date from concerned authority. This newly calculated rent will be part of renewal agreement and to be clearly mentioned while signing the agreement. This new rent will be effective from date of finalization of such rent by appropriate rent authority. Till then the already existing rent should be paid by the private partner. MSVP is requested to initiate the process urgently.

The agreement will be prepared on non judicial stamp paper of Rs. 100/- by the private partners for running the Fair Price Medicine Shops. It is also to be noted that the performance security has to be renewed in the form of Bank Guarantee with any nationalized bank, to be furnished by the private partners while executing the agreement. The performance security is to be executed with the concerned bank in non judicial stamp paper of Rs. 100/- . The duly completed bank guarantee needs to be provided as scheduled 3 of the agreement.

The possession Certificate has to be renewed as provided in schedule 2 of the agreement format attached in Annexure –I.




